Begin at **Cibolo Green Elementary School, 24315 Bulverde Green, San Antonio, Texas 78261**

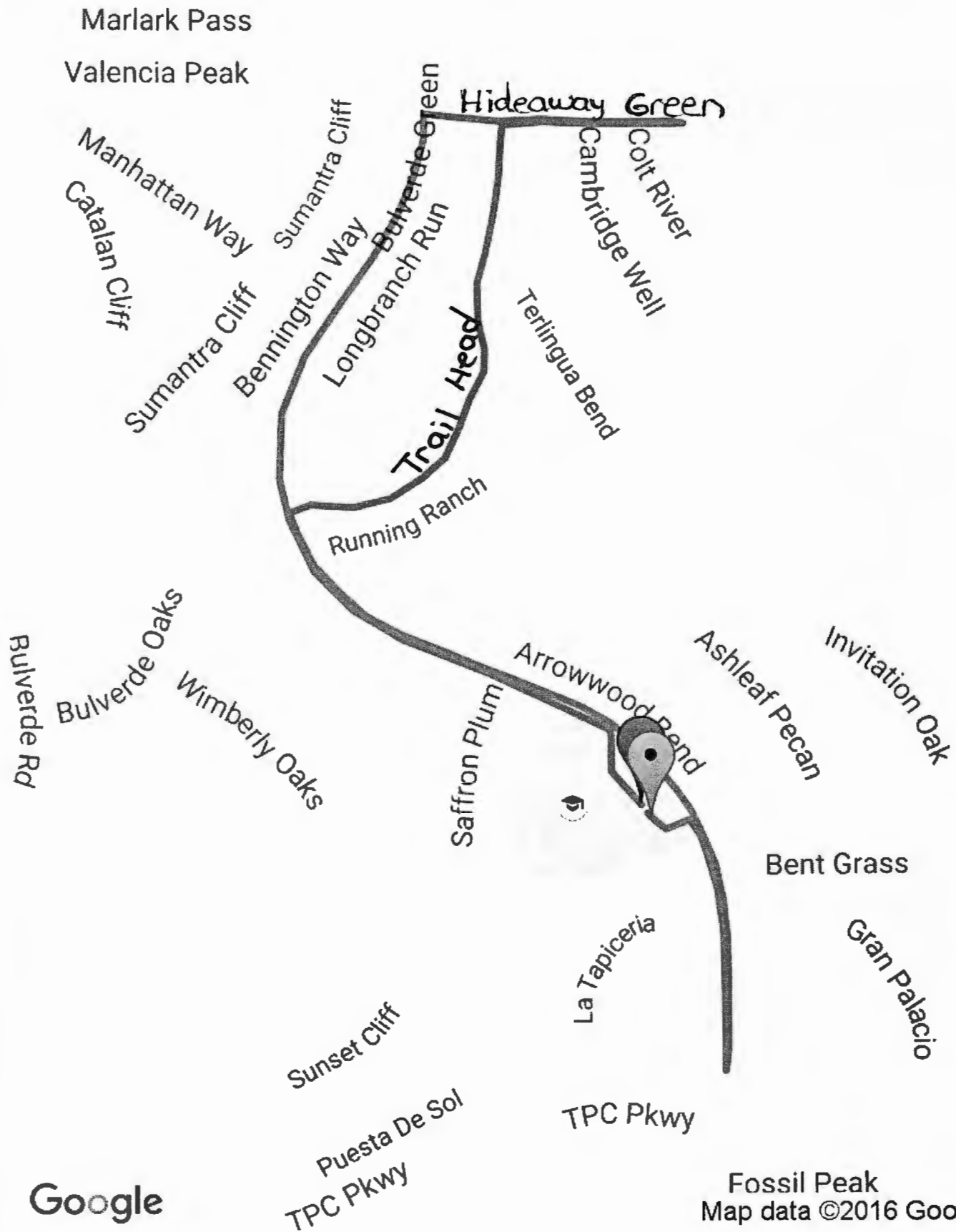
Right on **Bulverde Green Road**, continue .32 miles and loop back up **Bulverde Green Road**

Left on **Bulverde Green Road** back to **Cibolo Green Elementary School**.
